The agency head reviews the hiring package, approves the hire and sets (with OIG recommendation) a salary consistent with the salary of others in the same or similar positions in the department. Once a start date is established, the agency head, chief of staff or assistant secretary signs the hire offer letter. The OIG provides this letter to the prospective hire.
