

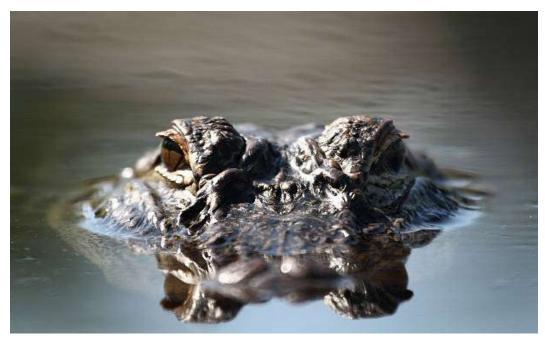

INTRODUCTION

In accordance with Section 20.055 Florida Statutes (FS), the Florida Fish and Wildlife Conservation Commission (FWC) Office of Inspector General (OIG) is "established...to provide a central point for coordination of and responsibility for activities that promote accountability, integrity, and efficiency in government." The mission of the OIG is to "provide leadership in the promotion of accountability and integrity in state government." The OIG is required by Section 20.055(8)(a) FS to complete an annual report summarizing its activities for the prior fiscal year and to submit that report to the agency head. The report must include, but is not limited to, the following:

- A summary of each investigation and audit completed during the reporting period.
- A description of activities relating to the development, assessment, and validation of agency performance measures.
- A description of significant abuses and deficiencies relating to the administration of programs and operations of the agency disclosed by investigations, audits, reviews, or other activities during the reporting period.
- A description of recommendations for corrective action made by the Inspector General during the reporting period with respect to problems, abuses, or deficiencies identified.
- The identification of each significant recommendation described in previous annual reports on which corrective action has not been completed.





EXECUTIVE SUMMARY

This annual report provides an overview of the FWC OIG's investigative and audit activities during the 2024-2025 fiscal year (FY). The following accomplishments, highlights, and activities demonstrate the efforts of the OIG during the past fiscal year:

- Received, reviewed, and processed 242 complaints or requests for assistance from our internal and external stakeholders. This constitutes an 8% decrease from 261 the prior FY.
- Initiated 31 investigations and inquiries into allegations of violations of statutes, rules, policies, and contracts based on complaints received that met our investigative criteria. This constitutes a 23% decrease from 38 the prior FY.
- Responded to 56 public records requests pursuant to Chapter 119 FS.
- Issued 30 final investigative reports containing recommendations for improvement to agency leadership.
- Conducted seven outreach training sessions which consisted of providing employee education on fraud, waste, and abuse prevention.
- Conducted two pre-employment background investigations for potential new employees.
- Maintained accreditation through the Commission for Florida Law Enforcement Accreditation (CFA) for the OIG Investigations Section.

FWC OIG GOALS AND VALUES

The FWC OIG operates on a set of shared goals and values. FWC OIG goals include:

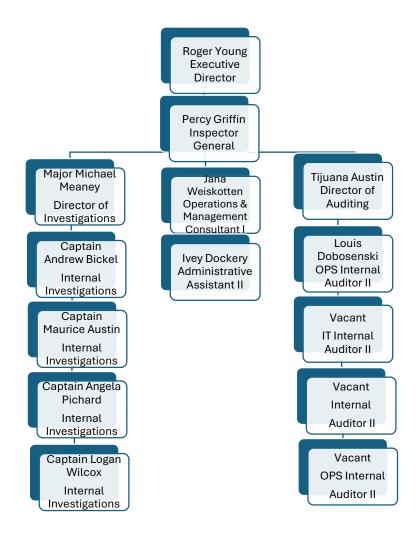
- Detecting and deterring fraud, waste, and abuse.
- Identifying trends.
- · Creating ethical awareness within the agency.
- Improving accountability.
- Ensuring fair, thorough, and impartial investigations.
- Ensuring audits add value to the agency.
- Reducing agency liability and risk; and
- Ensuring reliability and validity of agency performance measures.

FWC operates on six core values, four of which are directly aligned with the FWC OIG mission. These shared agency values include service excellence, teamwork/collaboration, professional integrity, and accountability. The FWC OIG strives to achieve these goals by meeting the needs of our internal and external stakeholders, working across division/office lines to resolve challenges, all while promoting integrity and accountability in support of the agency's overall conservation mission.



PROFESSIONAL STAFF

The FWC OIG prides itself on maintaining a highly trained and motivated staff. The professional staff of the OIG is made up of 13 positions, including the Inspector General, a Law Enforcement Major (Director of Investigations), the Director of Auditing, four Law Enforcement Captains (Investigators), an Information Technology (IT) Internal Auditor II, three Internal Auditor IIs, an Operations & Management Consultant I, and an Administrative Assistant II. Twelve of the 13 staff members employed during the fiscal year possessed a college degree from an accredited college or university, and four of those staff members possessed graduate degrees. During the fiscal year, three audit positions were vacated. These positions are currently anticipated to be filled during the next fiscal year. The FWC OIG employs 10 members as of the date of this report on September 30, 2025.

PROFESSIONAL CERTIFICATIONS AND TRAINING

FWC OIG staff members employed during the fiscal year held the following professional certifications:

Some of these certifications are mandated by Florida law. Virtually all certifications require regular mandatory training courses, such as annual in-service training for law enforcement officers, investigative and audit training, fraud awareness training, and ethics training. For FY 2024-2025, OIG staff completed over 1,412 hours of training.



SUMMARY OF INVESTIGATIVE ACTIVITIES

The FWC OIG Investigations Section reviews all criminal and administrative allegations of misconduct against FWC employees, contractors, and recipients of FWC funds. The OIG also investigates alleged violations of Florida's Whistle-Blower Act. Each complaint received is reviewed by OIG Investigations Section staff to determine if it meets the investigative criteria in FWC Internal Management Policy and Procedure (IMPP) 1.8 – Office of Inspector General, and additionally, if there is sufficient, credible information to warrant a formal investigation.

Minor complaints as defined in IMPP 1.8 include, but are not limited to, allegations of rudeness, use of obscene or profane language, personal appearance issues, improper operation of a state vehicle or vessel, a citizen complaint that can be resolved in the initial contact, and routine disciplinary action by a supervisor which results in counseling or a verbal or written reprimand. The originating FWC division/office (D/O) addresses minor complaints after notifying the OIG of the complaint. The OIG will provide investigative assistance to the D/O as needed. Major complaints, as defined by IMPP 1.8, are investigated by the OIG.



COMPLAINTS REVIEWED

The FWC OIG Investigations Section received 242 complaints during FY 2024/2025. Complaints are designated with a "COM" case number. The following is a summary of the nature of each complaint and the outcome.

INVESTIGATIONS AND INQUIRIES

The FWC OIG Investigations Section conducts investigations of complaints alleging major misconduct and criminal activity if there is sufficient credible information to warrant a formal investigation. Examples of these types of complaints include, but are not limited to, allegations of criminal conduct, misconduct that if proven, will likely result in suspension or dismissal, violations of Florida's Whistle-Blower Act, misconduct that crosses D/O lines, and sexual harassment. Investigations are designated using an "INV" case number.

The Investigations Section also conducts inquiries. Inquiries are conducted when there is not enough information provided in the initial complaint to determine if an investigation is warranted. The inquiry is limited to obtaining enough information to make an informed decision as to how to designate the complaint. Inquiries are designated using an "INQ" case number.

Each allegation investigated by the OIG is classified under one of the following conclusions of fact, or is administratively closed:

- Exonerated The alleged conduct occurred but was lawful and proper.
- **Unfounded** There was no evidence identified in the investigation to support the allegation in the complaint.
- Not Sustained There was insufficient evidence to prove or disprove the allegation.
- Sustained The allegation was supported by proper and sufficient evidence.
- Policy Failure The alleged actions occurred but were not addressed by agency policy.
- **Closed** Used for inquiries where no information supporting further investigation was identified, or investigations which were administratively closed without a finding.
- Open Investigation was still open as of the time of this report.
- Arrest The subject of the investigation was arrested for one or more criminal violations.

The OIG Investigations Section initiated 31 investigations and inquiries during FY 2024/2025. The following is a summary of the nature of allegations and findings for each activity. More specific information regarding OIG investigations is not provided in this report due to confidential and/or exempt information contained within, and in some cases, ongoing disciplinary or legal processes. At the conclusion of each investigation, findings are issued based on all evidence gathered. The closed investigation is then provided to the originating D/O to determine the appropriate disciplinary action, if any. Some investigations include multiple allegations and multiple findings. Findings regarding the primary allegation are shown in this report.

SUMMARY OF AUDIT ACTIVITES

The FWC OIG Internal Audit Section is committed to providing independent, objective assurance and consulting services that add value and improve the operations of the FWC. This report summarizes the section's activities during the fiscal year ended June 30, 2025.

All audit engagements were conducted in accordance with either the International Standards for the Professional Practice of Internal Auditing (Red Book) issued by the Institute of Internal Auditors, or the Generally Accepted Government Auditing Standards (GAGAS) (Yellow Book) as published by the United States Government Accountability Office.



AUDITS

The role of internal auditing is to provide an independent, objective assurance and consulting activity designed to add value and improve the organization's operations. The Internal Audit Section assists the agency in accomplishing its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, control, and governance processes. The FWC OIG Internal Audit Section provides assurances to senior management that all reviewed operations are performed in a manner consistent with established organizational objectives, policies, and procedures. The following summaries describe the audit activities performed during the fiscal year.

Florida Youth Conservation Centers Network Compliance Audit (23-0019-IA)

The purpose of this audit was to determine if Florida Youth Conservation Centers Network (FYCCN) has written policies and procedures and if there was adequate documentation to support youth camper registration payment records. This audit was not completed due to limited resources and staffing changes. This audit was administratively closed prior to the issuance of this report.

HSC (PASO) Construction Contract Audit (23-0020-IA)

The purpose of this audit was to review the contract and contract change orders as a compliance audit of FWC Agreement No. 21310 between the Agency and Sea & Shoreline, LLC. This audit was not completed due to limited resources and staffing changes. This audit was administratively closed prior to the issuance of this report.

HGM Construction Contract Audit (24-0067-IA)

The purpose of this audit was to review the contract and contract change orders as a compliance audit of FWC Contract No. 22279 between FWC and Arris General Contractors Inc. This audit was not completed due to limited resources and staffing changes. This audit was administratively closed prior to the issuance of this report.

Triennial Contract Compliance Audit (24-0068-IA)

The objective of this audit was to conduct a risk-based compliance audit of all contracts procured under Chapter 287, Florida Statutes, and executed by the Agency during the 2021-2022 through 2023-2024 fiscal years. In accordance with section 287.136(2), FS, the audit included an evaluation and identification of any trends in vendor preferences. This audit was placed on hold due to available staffing resources.

Cybersecurity Audit – Asset Management (24-0069-IA)

The objective of this audit was to evaluate agency controls and compliance with asset management requirements contained in the Florida Cybersecurity Standards (Rules 60GG-2.001 through 60GG-2.006, Florida Administrative Code (FAC)), with a focus on 60GG-2.002(1), FAC. This audit was not completed due to limited resources and staffing changes. This audit was administratively closed prior to the issuance of this report.

Fuel Card Program Audit (25-0001-IA)

The objective of this audit is to review and evaluate the Commission's Fuel Card program and determine compliance with applicable law, policy and/or procedure.

MANAGEMENT REVIEWS

Internal Quality Assurance Review (24-0070-IA)

The purpose of this review is to conduct an internal assessment of the Internal Audit Section's compliance with Government Auditing Standards (Yellow Book) (rev. 2024).

Mobile Radios Management Review (25-0002-IA)

The purpose of this review is to evaluate the agency's adherence to IMPP 5.8, IMPP 5.9, and Interim Policy Memorandum 2022-02 as they pertain to the management of mobile radios. The review will assess the effectiveness of internal controls, identify any areas of non-compliance or procedural gaps, and provide recommendations to strengthen compliance and ensure alignment with agency standards.
